PRE-BREEDING ARRANGEMENTS: The mare owner must provide the following when booking a contract:

- Copy of both sides of registration certificate
- Completed information sheet
- Signed breeding contract
- Proof of current veterinary reproductive exam and normal uterine culture and/or cytology.
- All applicable fees paid: The stud fee/chute/booking and shipping fees must be paid in full before any semen will be shipped.
- * Mares staying at BCVC for breeding must have current Coggins and vaccine records on file with manager.

SHIPPING / ORDERING:

- Please check with BCVC to find out the shipping schedule for the stallion. Normal collection days are **MONDAY, WEDNESDAY, FRIDAY**. It is the mare owner's responsibility to confirm our collection days.
- Mare owner or agent must give at least 24-hour notice to BCVC of possible semen order and confirm
 by 8am central time day of collection. NO guarantee will be made that cooled semen will be available
 on a given day. It is first call, first serve.

TO ORDER SEMEN text or call Heidi 281-732-2604 before 5pm. Must get return text message within 1 hour. If there is no response, then make sure to text again or call 979-429-7008 and leave a message.

- Every effort will be made to accommodate your mare's breeding timeframe; however, it is the mare owner's responsibility to keep in touch with BCVC so that your veterinarian and ours can get your mare in foal. A veterinarian or technician knowledgeable in successful insemination techniques must oversee off-site inseminations in order to maximize the potential of a timely pregnancy.
- Additional cooled semen for mares breeding at BCVC pay a chute fee of \$350 per dose.
- Additional cooled semen for pickup from BCVC pay a chute/processing/packaging fee of \$450 per dose.
- Additional cooled semen sent via FedEx Overnight within the United States pay a chute/processing/packaging/ shipment fee of \$600 per container.
- BCVC is NOT responsible for the COSTS arising from shipments lost, damaged, or delayed in transit, or condition of cooled shipped semen upon delivery. We have no control over the shipment once it leaves our facility!
- The mare owner agrees to have the mare checked within 30 days of insemination and report back to BCVC with results of pregnancy.
- The owner agrees to have the semen shipping container returned to BCVC from the administering
 veterinarian or breeding facility manager back to BCVC within 7 days of delivery. If shipping container is
 not returned within 7 days, the mare owner will be charged \$50 per container.
- The mare owner is also responsible for DNA testing their mare as per AQHA and APHA rules.
- MARE WILL NOT BE PUT ON BREEDING REPORT UNLESS ALL FEES HAVE BEEN PAID IN FULL, PREGNANCY STATUS, AND LAST BREEDING DATE HAS BEEN PROVIDED TO BCVC.

LIMITED LIVE FOAL GUARANTEE

- If the contracted mare dies or is deemed unfit to breed during the season she is contracted, a substitute mare, approved by the stallion owner, may be bred without any additional breeding fee for that same season. NO REFUNDS GIVEN ON ANY FEES ASSOCIATED WITH THIS CONTRACT!!
- A live foal is defined as one that will stand and nurse. If foal is born dead, mare owner agrees to furnish the stallion owner, within 7 days, a certification from a licensed veterinarian that the foaling was an attended foaling and deliver a written statement from the veterinarian giving details on the failure of the mare to produce a live foal. In such a case, the mare owner will have the right to rebreed the contracted mare the season following the original contract only. A different mare may be substituted for rebreeding at the stallion manager's discretion. In such a case, return privileges will be available for the season following the original contract season.
- All rebreeds must pay the rebreed chute fee of \$350 + any shipping and processing charges applicable. (\$250 FedEx or \$100 On-Site Pickup). If the mare owner fails to rebreed a mare the following year after the original contracted season, then the right to rebreed is cancelled. All fees become forfeited, and the stallion owner is released from all, agreed in writing, and signed by both parties. initials here.

OTHER REQUIREMENTS

ANY MARE THAT IS TO BE REBRED MUST HAVE A CLEAN NEGATIVE CULTURE ON FILE WITH BCVC BEFORE ANY SEMEN WILL BE SENT.

- We DO NOT offer color guarantee on APHA and ApHC registered mares.
- EMBRYO TRANSFERS: If more than one embryo is produced from a single flush, then the mare owner is required to sign an additional contract for the additional embryo and pay an additional stud fee of \$750 for each additional embryo.
- If something should happen to the stallion, My Merada Cat, where he can no longer be a standing stallion, whether hurt or deceased, then the stud owner, Lawerence Cedric Cooks, will refund the stud fee of \$750. The booking/chute/processing/shipping/vet fees are non-refundable.
- All parties acknowledge that this agreement is made and performed within the County of Matagorda, State of Texas. Both parties agree should any dispute or claims arise regarding this contract, the venue will be in the State Court located in Matagorda County, Texas and shall be construed and enforced under the laws of the State of Texas. Both parties agree that at no time will any damages ever be awarded in any amount greater than the actual stud fee that was paid.

All payments may be made by check or credit card (Visa, Mastercard, American Express, Discover, Care Credit) and be in US funds. All shipping and charge fees are subject to change. Payments must be made in full prior to semen being shipped.
